



2017 Colorado Classic Stallion Incentive Program

The Colorado Classic Stallion Incentive Program is for foals sired by stallions nominated to the Colorado Classic Stallion Incentive. Foals are eligible for the Colorado Classic incentive side pots during their eligibility year if stallion is enrolled in that current competition year, or if stallion was enrolled in their year of birth. Beginning in 2017 if you drop your stallion out of the breeders' program and wish to be reinstated you must pay yearly catch up fees of \$250/year.

OPTION 1

___ NOMINATE STALLION

\$350 Nomination due in office by **1/24/17** - the earlier we receive nomination fee the earlier your stallion will be advertised!
(Stallion is NOT included in stallion auction)

OPTION 2

___ NOMINATE STALLION BY DONATING BREEDING TO STALLION AUCTION.

Minimum bids start at \$350 unless a higher minimum is designated by stallion owner. If minimum bid is not met stallion owner is responsible for paying \$350 for stallion enrollment.

Note if you choose option 2 you must fill out stallion auction form on attached page.

All proceeds collected from the Colorado Classic Stallion Incentive and Auction will go towards added money for the 2017 Colorado Classic Futurity and Derby. Money will be split as follows: 35% to stallion incentive futurity, 30% to open futurity, 15% to stallion owners' payout, 10% to stallion incentive derby and 10% for advertising and promotion.

4. The bidding will begin at not less than \$350. Stallion owner can increase minimum bid if desired. If \$350 minimum bid is not met, stallion owner is responsible for paying \$350 fee for stallion's progeny to remain eligible.
5. Bids will be accepted in \$50 increments and only accepted through the Colorado Classic Stallions website – coloradoclassicstallions.com.
6. Bidders may place a maximum bid and will be notified when/if they are outbid via email.
7. A live foal guarantee is required with this contract. A contract must be emailed to coloradoclassicfurity@gmail.com. This contract will be sent to the winning bidder.
8. You will be provided with the name, address and phone number of the winning bidder upon conclusion of the stallion auction and receipt of payment. It is up to you and the winning bidder to make contact and arrangements.
